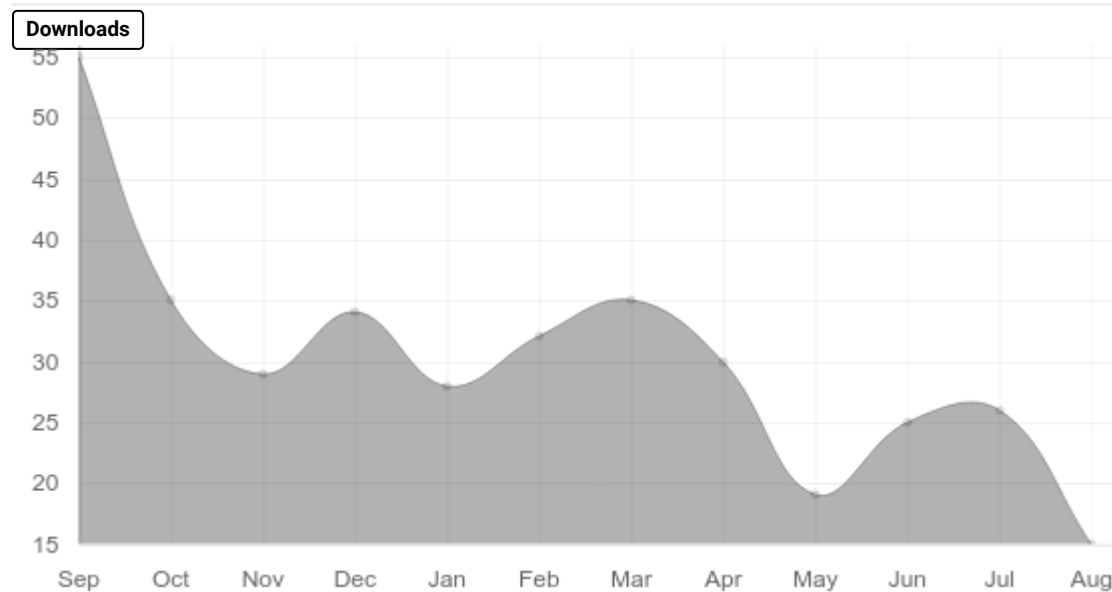

Abstract
